EXTRACT FROM THE MINUTES OF THE REGULAR SESSION OF THE SANGGUNIANG BAYAN OF HUNGDUAN, IFUGAO HELD AT THE SANGGUNIANG BAYAN SESSION HALL ON FEBRUARY 4, 2002 AT 9:00 AM.

MUNICIPAL ORDINANCE NO. 01

Series of 2002

AN ORDINANCE PRESCRIBING THE MANDATORY WEARING OF THE IFUGAO ATTIRE BY ALL MUNICIPAL OFFICIALS, EMPLOYEES AND BARANGAY OFFICIALS IN THE PARADE, OPENING PROGRAM AND FOR OTHER PURPOSE DURING THE TUNGOH AD HUNGDUAN AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

Be it Ordained by the Sangguniang Bayan of Hungduan, Ifugao in session assembled that;

Section 1. TITLE: This Ordinance shall be known and cited as the “TUNGOH ORDINANCE”

SECTION 2: POLICY: It shall be the policy of the Municipal Government to require the mandatory wearing of the Ifugao attire by all municipal officials, Employees and Barangay Officials of this Municipality considering that the TUNGOH AD HUNGDUAN, being celebrated annually is centered on the revival, preservation and promotion of our cultural values and the Presentation of ethnic games and rituals to counter the shame of the people to wear in public the Ifugao attire causing them to forget the proper way of wearing the same.

Section 3. DEFINITION OF TERMS:

- A. **Tungoh** - means rest day after planting season in anticipation of a bountiful harvest usually celebrated in the Municipality of Hungduan in the month of April.
- B. **Ifugao Attire** - refers to which is usually worn by the people of Hungduan when presenting of performing Ifugao customs/ rituals that includes but not limited to: Wanoh, pongot, bitug, ponggoh, bayaong, hinalung, and ginuttu (for men), and Ampuyo, mayad, padang, ang kabbaong/ beads (for women)
- C. **Cultural Values** – refers to man’s social heritage which has been transmitted from one generation to another.
- D. **Recidivist** - shall refer to habitual offender
- E. **Barangay Officials** – Shall refer to elective officials in the Barangay including the Barangay secretary and treasurer.

Section 4. COVERAGE; This ordinance shall apply to all Municipal Officials, Barangay Officials and Employees in the Municipality of Hungduan.

Section 5. PROHIBITED ACTS: failure on the part of any Municipal Officials, Employees and Barangay Officials to wear or observe the proper wearing of the Ifugao attire or anybody who without justifiable cause shall fail to attend the parade and opening program for the purpose of evading the wearing of the Ifugao attire are hereby declared prohibited acts.

Section 6. PENALTY: Any violation of section 5 of this ordinance shall be penalized as follows, to wit:

| D. For recidivist, the penalty shall be twice the prescribed penalties herein above stated. | |

Section 7. Funds derived from the preceding section shall accrue to the trust fund of the Municipal Government.

Section 8. Penalties for any violation of this ordinance shall be deducted from the quincenas or monthly salary of the Municipal Official or Employee concerned by the Municipal Treasurer and from the honoraria of Barangay Officials by their respective Barangay treasurer.

Section 8. ENFORCEMENT/IMPLEMENTATION- This ordinance shall be enforced by the Local Chief Executive or his duly authorized representative in the case the Municipal Officials and Employees and the Barangay Captain or his duly authorized representative in the case of Barangay Officials. The implementing Officials shall endeavor to check and take the list of those who do not adhere to the mandate of this ordinance as basis in the collection of penalties.

Section 10. Any previous ordinance not consistent with the provisions of this ordinance are hereby repealed and superseded.

Section 11. EFFECTIVITY: This ordinance shall take effect immediately after its approval
