AN ORDINANCE GRANTING CASH INCENTIVES TO CULTURAL PERFORMERS WHO PERFORMS CULTURAL SHOWS AND NATIVE RITUALS DURING SPECIAL OCCASIONS SPONSORED BY THE MUNICIPAL GOVERNMENT OF HUNGDUAN, IFUGAO PROVINCE AND PROVIDING FUNDS THEREOF.

WHEREAS, person or group of persons utilized by the Municipal Government to simulate native customs and rituals during special occasions contributes not only to the preservation of our time-honored customs and traditions but also to the promotion of tourism industry in the Municipality;

WHEREAS, most of the cultural performers who are always readily available to perform such activities are senior citizens and farmers who are often disrupted from their works resulting to a day's loss of income aside from undergoing the rigors and hardships during their practice sessions;

WHEREAS, in order that these cultural performers maybe able to give their best they should be provided with incentives from the Municipal Government, one form of which is to grant cash incentives;

WHEREAS, the cash incentives may be drawn from the Municipal Tourism fund of the Municipal Government.

NOW THEREFORE, on motion of Honorable Ricardo Basilio and was duly seconded;

Be it ordained by the Sangguniang Bayan of Hungduan, Ifugao in session duly assembled that;

SECTION I. It shall be the policy of the Municipal Government to give cash incentives to cultural performers called by the Municipal Government to perform native customs and rituals in the outside the municipality during special occasions;

A cultural performer maybe defined as one who simulates native customs and rituals and acts for the benefit of tourists and visitors of the municipality;

SECTION II. The amount of cash incentives shall be as follows:

P200.00 – for each individuals performing within the municipality.
P300.00 – for each individuals performing outside the municipality.

The cash incentives shall be given to each individual participant after the occasion.

SECTION III. The cash incentives shall be drawn from the municipal tourism fund of the Municipality of Hungduan, Ifugao.

SECTION IV. This ordinance shall take effect upon approval by the Sangguniang Panlalawigan of Ifugao or thirty days (30) from submission thereof without action.
