**MUNICIPAL ORDINANCE NO.01
Series of 2004**

AN ORDINANCE ESTABLISHING AN INTEGRATED PROGRAM FOR RENEWAL AND ADVANCEMENT OF THE YOUTH OF THE MUNICIPALITY OF HUNGDUAN, IFUGAO AND PROVIDING THEREOF.

SECTION 1. TITLE. This ordinance shall be known as An Integral Program for Renewal and Advancement of the Youth otherwise known as I-PRAY Ordinance.

SECTION 2. DECLARATION OF POLICY. It shall be the policy of the Local Government unit of Hungduan, Ifugao to provide for opportunities to the youths for the development of their physical, moral, spiritual, intellectual, and social well-being and improve their quality of life.

SECTION 3. COVERAGE. Any person residing in the Municipality of Hungduan, Ifugao upon reaching thirteen years of age is qualified as youth member and shall be determined upon reaching Thirty years of age as defined under the provisions of RA 8044, otherwise known as the “Youth in Nation Building Act”. It shall include the In-School Youth (ISY), out- of School Youth (OSY) working youth (WY) and Youth with Special Needs (YWSN).

SECTION 4, PURPOSE AND OBJECTIVE. This ordinance shall have the following purposes and objectives:

- a. To provide opportunities for skills development among the youth in the community.
- b. To instill moral values and spiritual growth among the youth.
- c. To provide opportunity for unity and cooperation among the youth through sports activities.
- d. To empower the youth for effective and responsible social functioning.
- e. To inculcate policies and programs intended for the protection and preservation of the Ifugao Cultural Heritage.
- f. To protect the youth from the menace of drug addiction and other forms of abuse and arrest them from the tendencies of juvenile delinquency.
- g. To coordinate with government agencies, private organizations and the religious sectors for moral, technical and financial support which can best provide them.

SECTION 5. PROGRAM COMPONENTS. The Integrated Program for Renewal and Advancement of the Youth (I-PRAY) shall have the following program components:

- a) **Leadership Development** - conduct trainings and symposia on peer assistance leadership for students at the Hungduan National High School, others school that maybe established in the Municipality and interested out of school youth this municipality;
- b) **Values Development** – conducts trainings, workshop and symposia on values development by adopting the principles and strategies of the moral recovery program of the national development.
- c) **Sports Development** -conducts sports competitions among the youth by adopting the concepts and strategies of the Philippines Sports Commission on the Palarong Pambayan in coordination with the Philippine Sports Commission and Department of Education (DepEd).
- d) **Skills Development** - provides financial assistance to interested youth to undergo skills development trainings and schooling conducted by Government Agencies or Private organizations.
- e) **Cultural Development** - conduct trainings on cultural dances, music, chants, and arts and crafts intended for the preservation of the Ifugao cultural heritage in the coordination with the NCCA.
- f) **Livelihood Development Program** -conduct trainings on agriculture, trade and industry.

SECTION 6. IMPLEMENTATION. The Municipal Social Welfare and Development Office (MSWDO) shall be the lead office in the implementation of this ordinance in close coordination with the Municipal, Barangay and Sangguniang kabataan Officials and the Students Government Organization of Hungduan National High School.

The public Information Office of the Municipal Government and the Department of Education and the religious sectors of the Locality shall serve as support role which task is the spearhead information drive on this Integrated Youth Development program and assist the office of the Municipal Development Office in the conduct of trainings and seminars relative hereof.

In this connection, the Municipal Social welfare and Development Office shall formulate the implementing rules and regulations of this ordinance to be approved by the local chief executive /such implementing rules and regulations must be in accordance with the intent, purpose and provisions of this ordinance.

SECTION 7. FUNDING SOURCE. The amount of at least One Hundred Thousand pesos (P100,000.00) shall be appropriated in the annual budget of the local government unit under the Twenty percent (20%) Development Fund immediately upon approval of this ordinance. However, for year 2004, the amount of Seventy Thousand Pesos (P70,000.00) appropriated Assistance to Youth Development under the Twenty Percent (20%) Development Fund shall be utilized as initial funds for the program and can be augmented thru a supplemental budget.

SECTION 8. EFFECTIVETY. This ordinance shall take effect thirty (30) days after its publication within the locality following its approval.

RESOLVED FURTHER, to furnish copies of this resolution to the office of Sangguniang Panlalawigan, capitol Compound, Lagawe, Ifugao for their information and favorable action.
