MUNICIPAL ORDINANCE NO. 2010 – 26b

AN ORDINANCE ABOLISHING THE POSITION, LEGISLATIVE STAFF OFFICER I (LSO I) FROM THE POSITION ALLOCATION LIST OF THE LOCAL GOVERNMENT UNIT OF HUNGDUAN, IFUGAO.

WHEREAS, presented to this body is the Municipal Ordinance No. 21. Series of 2006 adopted and approved on September 18, 2006. *A copy of which is hereto attached and made an integral part hereof;*
