EXECUTIVE ORDER NO. 02 **Series of 2015**

AN ORDER RECONSTITUTING THE LOCAL POVERTY REDUCTION ACTION TEAM (LPRAT) OF THE LOCAL GOVERNMENT UNIT OF HUNGDUAN, IFUGAO

Whereas, the national government agencies and other stakeholders shall pursue the Millennium Development Goal of reducing poverty from 26.5% to 16.6% by 2015;

Whereas, the Local Government Code of 1991 mandated community participation in the Local Development Councils and various organized local special bodies;

Whereas, DBM-DILG-DSWD-NAPC Joint Memorandum Circular No. 5, Series of 2014, provided the policy guidelines and procedures in the implementation of the Grassroots Participatory Budgeting Process for the preparation of the FY 2016 Budget and the succeeding years;

Whereas, as per policy guidelines, the need to perform as well as collect efforts from the Municipal Government, National/Regional Line Agencies, Civil Society Organizations, Basic Sectors, the community and other stakeholders concerned is vital towards reducing poverty by 2015;

Whereas, to strengthen and concretize the implementation of the Grassroots Participatory Budgeting Process in the locality, JMC No. 5 series of 2014 provides for the new composition of the expanded Local Poverty Reduction Action Team;

Now therefore, I HILARIO T. BUMANGABANG, Municipal Mayor of Hungduan, Ifugao, by virtue of the powers vested in me by law, do hereby reconstitute the expanded Local Poverty Reduction Action Team (LPRAT) with its composition and functions, do hereby declare:

Section 2. ROLES AND RESPONSIBILITIES

The LGU- Local Chief Executive shall:

- Organize and convene the LPRAT
- Make available information and data sets about unmet needs and corresponding Annual Investment Programs and existing work and financial plans that already begin to address these unmet needs;
- Identify difficulties encountered by the LGU in its effort to reach remote barangays, respond to demands of basic sector groups and scale-up essential services such as those implied by core local poverty indicators of the CBMS and supply-side gaps relevant to Pantawid Pilipino and Universal HealthCare;
- Ensure conduct of LPRAP workshop/s with strong CSO and basic sector participation and ensure that only project proposals included in the LPRAP and prioritized by the LPRAT are submitted to the RPRAT;
- Ensure the conduct of quarterly LPRAT meetings; and

- Mobilize the LGU to comply with the requirements of the DILG's Seal of Good Housekeeping and implement its PFM Improvement Plan.

The Local Poverty reduction Action Team (LPRAT) shall:

- Organize and facilitate the conduct of a Local Poverty Reduction Action Planning workshop for the formulation of the LPRAP and the identification of priority poverty reduction projects;
- Agree on a list of priority poverty reduction project based on the LPRAP and submit it to the RPRAT using the proper template; and
- Conduct quarterly meetings to monitor the status of the approval and integration of priority poverty reduction projects into the budgets of participating agencies and monitor the implementation and status of the projects.

The Sangguniang Bayan shall:

- Review and approve the List of Priority Poverty Reduction Projects to be submitted to the RPRAT through a resolution using the prescribed from "Form C".

The CSO members of the LPRAT shall:

- Capacitate the communities, including the use of poverty-relevant database, as they participate in the local planning and budgeting processes;
- Facilitate their own meetings, community consultations and workshops in preparation for the LPRAP workshop;
- Actively participate in the formulation of LPRAP and identification of the Priority Poverty Reduction Projects;
- Through their elected representatives, endorse the LPRAP and list of poverty reduction projects for approval of the Sangguniang Bayan; and
- Monitor the implementation of the projects through LPRAT, the mechanism to be established by NAPC and/or through their own initiative.

Section 3. SECRETARIAT

The Secretariat of the LPRAT shall be the Municipal Agriculture Office being the LPRAT coordinator.

Section 4. EFFECTIVITY

This order shall take effect immediately and shall be in full force and effort until repealed, amended, or modified.
