### **EXECUTIVE ORDER NO. 20** **Series of 2014**

#### **AN ORDER MANDATING THE ORGANIZATION OF PANTAWID PAMILYA – BARANGAY ADVISORY COMMITTEE (BAC) IN ALL BARANGAYS IN THE MUNICIPALITY OF HUNGDUAN, IFUGAO.**

**WHEREAS**, the Pantawid Pamilyang Pilipino Program (Pantawid Pamilya) is a rights-based program that focuses on human capital investment through provision of health and education cash grants to eligible poor households. It is one of the poverty reduction strategies of the national government to enable poor households to meet certain human development goals aimed at breaking intergenerational cycle of poverty;

**WHEREAS**, Advisory Committees are created at the national, regional, provincial, municipal and barangay level by virtue of Department of Social Welfare and Development (DSWD) Memorandum Circular 09, series of 2007 and Memorandum Circular 01, series of 2009, to craft guidelines and ensure the implementation of the program at the respective levels;

**WHEREAS**, by virtue of the Pantawid Pamilya – Municipal Advisory Committee Resolution No. 2014 – 01, Pantawid Pamilya - Barangay Advisory Committee (BAC) in all barangays in the municipality of Hungduan, Ifugao shall be organized providing functions and composition to ensure the implementation of the program at the barangay level;

**WHEREAS**, there is a need to address issues and concerns pertaining to Pantawid Pamilyang Pilipino Program at the barangay level;

**WHEREAS**, a committee at the barangay level will respond to the immediate needs of the Pantawid beneficiaries and certificate due process in resolving complaints and grievances related to project implementation at the barangay level.

**NOW THEREFORE, I, HILARIO T. BUMANGABANG**, Municipal Mayor of Hungduan, Ifugao, under the power vested in me by law, do hereby order to mandate the organization of Pantawid Pamilya – Barangay Advisory Committee (BAC) in all barangays in the municipality of Hungduan, Ifugao with the following compositions and functions in accordance as follows:

#### **SECTION 1. Composition of the Barangay Advisory Committee**

Chairperson	Barangay Captain
Vice Chairperson	DSWD staff
Members:	Indigenous Peoples leader (who is the member of the Barangay Development Council)
	Barangay Kagawad Chairperson on Children's Welfare
	Youth Representative
	School Head
	Parent leaders
	Midwife assigned at the barangay

**SECTION 2. Functions.** The Panatwid Pamilya – BAC shall have the following functions:

- (1) Initiate measures to ensure the availability of education and health facilities at the barangay level.
- (2) Encourage the responsible use of cash grants by the beneficiaries.
- (3) Help ensure compliance of beneficiaries to program conditionalities.
- (4) Facilitate and address complaints, requests of poor families such as targeting for endorsement to MAC/PAC/RAC, as necessary.
- (5) Hold regular and special meetings,
- (6) Refer to MAC ineligibility concerns (with necessary data/profile).
- (7) Initiate activities to augment well-being of beneficiaries.
- (8) Help disseminate schedule of activities relative to Pantawid Program.

**Section 3. Effectivity.** This Order takes effects upon its approval.
