EXECUTIVE ORDER NO. 22 Series of 2014

AN ORDER REORGANIZING THE TECHNICAL WORKING GROUP (TWG) FOR THE FORMULATION OF THE ANCESTRAL DOMAIN SUSTAINABLE DEVELOPMENT AND PROTECTION PLAN (ADSDPP) OF THE MUNICIPALITY OF HUNGDUAN, IFUGAO

Whereas, every member of an indigenous community of Hungduan, Ifugao bears the developed norms and social system reflecting the common practices in his environment;

Whereas, RA 8371 or the Indigenous Peoples Rights Act (IPRA) of 1997 states the rights of the indigenous peoples for recognition, protection and promotion of ancestral domains, self governance, cultural integrity and the indigenous knowledge systems and practices;

Whereas, the Ancestral Domain Sustainable Development and Protection Plan (ADSDPP) is required by virtue of RA 8371 or the Indigenous Peoples Rights Act (IPRA) of 1997 as an instrument and plan for the sustainable development and protection of an ancestral domain;

Whereas, as per NCIP Administrative Order No. 1, Series of 2004, ADSDPP is a framework for the process of human development; an instrument to facilitate Free Prior and Informed Consent (FPIC) process; and shall be used to identify and prioritize development programs/projects to alleviate poverty among indigenous cultural/indigenous peoples communities;

Whereas, organization of the Technical Working Group (TWG) is a requisite with the representation of local government unit (LGU), people's organization (PO), and non-government organizations (NGO) for the formulation of the ADSDPP;

Whereas, there is a need to reorganize the Technical Working Group (TWG) for the Formulation of the Ancestral Domain Sustainable Development and Protection Plan (ADSDPP) of The Municipality of Hungduan, Ifugao in consideration to the changes in membership brought about by the recent election and new designation of key personnel of the Local Government Unit (LGU), PO and NGOs.

Now Therefore, I HILARIO T. BUMANGABANG, by virtue of the powers vested in me by law as the Municipal Mayor of Hungduan, Ifugao, do hereby order the reorganization the Technical Working Group (TWG) for the Formulation of the Ancestral Domain Sustainable Development and Protection Plan (ADSDPP) of the Municipality of Hungduan, Ifugao with the following provisions in accordance as follows:

Section 1. Composition. The TWG for the ADSDPP shall be composed of the community's traditional elders/leaders and sectoral representatives.

Section 2. Secretariat. The Office of the Municipal Mayor and the Municipal Planning and Development Office shall act as the Secretariat of the Technical Working Group for the Ancestral Domain Sustainable Development and Protection Plan and shall be responsible in taking and keeping records of the committee, making and sending communications upon coordination with the Chairperson and does other actions representing the committee.

Section 3. Functions. The TWG shall perform the following functions:

1. To draw up the Work and Financial Plan (WFP) which specifies the planning activities, their schedules, specific outputs, responsible persons or groups, and budgetary requirements and probable source of income;
2. Data gathering;
3. Data assessment;

4. Refines the IP/AD framework in close consultation with the elders and leaders of the ICC;
5. Design a monitoring and evaluation system to measure the progress of program implementation; and
6. Interface with other government policies, plans, and programs - the agencies shall include the DENR, DPWH, DA, DSWD, DOH, DepEd, DOJ, DND, DBM, NEDA and LGU

Section 5. Formulation Process of the ADSDPP. The ADSDPP shall be divided into four (4) phases where each phase is described in more detail with the different activities that need to be undertaken to accomplish the output expected from the completion of each phase. These phases include:

Phase I. Preliminary Activities and Social Mobilization

- A. Pre-planning Consultations
 - a.1. First Community Meeting
 - a.2. Second Community Meeting
- B. Organization of the Working Group/Planning Team
- C. Preparation of the Work and Financial Plan

Phase II. Data Gathering and Assessment

Phase III. Planning

Phase IV. Plan Promotion and Marketing

Section 6. Compensation and Remuneration

The members of the TWG shall perform their roles and responsibilities without compensation and remuneration. However, members who are not officials or employees shall be entitled to travelling expenses chargeable against the funds of the Office of the Municipal Mayor, subject to existing accounting and auditing rules and regulations.

Section 7. Effectivity

This order shall take effect immediately upon signing hereof and shall have full force and effective until repealed, amended, or modified.
