EXECUTIVE ORDER NO. 17 **Series of 2014**

AN ORDER DESIGNATING GENDER AND DEVELOPMENT (GAD) FOCAL PERSON FOR THE IMPLEMENTATION OF THE KALAHI-CIDSS-NCDDP PROJECT

WHEREAS, the Municipality of Hungduan has been selected as one of the sites for the implementation of Kapit Bisig Laban sa Kahirapan Comprehensive and Integrated Delivery of Social Services- National Community-Driven Development Program (KALAHI CIDSS - NCDDP) being implemented by the Department of Social Welfare and Development (DSWD);

WHEREAS, the KALAHI CIDSS - NCDDP aims to empower local communities through improved participation in Local Governance and involvement in the preparation and implementation of poverty reduction projects and consist among others the provision of grants to support sub-projects prioritized by the barangays;

WHEREAS, the programs compliments the goals and objectives embodied in the Comprehensive Development Plan of Hungduan and the local poverty reduction action plan;

WHEREAS, there is a need to assign a Gender and Development Focal Person to ensure the integration of Gender Sensitivity and Gender Responsiveness to support the implementation of the KALAHI CIDSS – NCDDP;

NOW THEREFORE, I, HILARIO T. BUMANGABANG, Municipal Mayor of Hungduan, Ifugao, under the power vested in me by law, do hereby declare.

Section 1. Designation. The Gender and Development Focal Persons relative to the implementation of the KALAHI CIDSS - NCDDP Program is hereby designated to:

Section 2. Powers and Functions. The Gender and Development Focal Person shall perform the following functions:

1. To serve as link between MLGU and KC-NCDDP concerning GAD.
2. To facilitate preparation of GAD Plan and to lead monitoring of its implementation.
3. To coordinate closely and to provide inputs to ACT for the integration of GAD Activities to KC-NCDDP.
4. To attend/participate activities and workshops of KC-NCDDP in relation to GAD concerns.
5. To prepare and submit reports to MIAC and KC-NCDDP with regards to GAD activities and concerns.
6. To prepare project proposal and facilitate request for fund release in relation to GAD activities, if required by KC-NCDDP.
7. To perform other related functions as required by the LCE and as requested by KC-NCDDP.

Section 4. Accountability and Reporting. The GAD Focal Persons shall ensure that appropriate reports and other project documents be provided to the Local Chief Executive and the municipal inter-agency committee.

Section 5. Effectivity. This Order takes effect upon its approval until revoked.
