EXECUTIVE ORDER NO.15 **Series of 2014**

AN ORDER CREATING OF THE MUNICIPAL INTER-AGENCY COMMITTEE (MIAC) FOR THE KALAHI CIDSS - NCDDP PROJECT IMPLEMENTATION OF THE MUNICIPALITY OF HUNGDUAN, IFUGAO

WHEREAS, the Municipality of Hungduan has been selected as one of the sites for the implementation of Kapit Bisig Laban sa Kahirapan Comprehensive and Integrated Delivery of Social Services- National Community-Driven Development Program (KALAHI CIDSS -NCDDP) being implemented by the Department of Social Welfare and Development (DSWD);

WHEREAS, the KALAHI CIDSS - NCDDP aims to empower local communities through improved participation in Local Governance and involvement in the preparation and implementation of poverty reduction projects and consist among others the provision of grants to support sub-projects prioritized by the barangays;

WHEREAS, the programs compliments the goals and objectives embodied in the Comprehensive Development Plan of Hungduan and the local poverty reduction action plan;

WHEREAS, to support the implementation of the KALAHI CIDSS – NCDDP program, there is a need to create the Municipal Inter-agency Committee (MIAC) to provide technical assistance to the barangays in the preparation of Barangay Development Plans and Barangay Sub-project proposals;

NOW THEREFORE, I, HILARIO T. BUMANGABANG, Municipal Mayor of Hungduan, Ifugao, under the power vested in me by law, do hereby declare.

Section 1. Composition

The Municipal Inter-agency Committee (MIAC) relative to the implementation of the KALAHI – CIDSS - NCDDP Program is hereby created and shall be composed of the following:

Section 2. Functions

The Municipal Inter-agency Committee shall perform the following functions:

1. Coordinate the programs and projects of the various member agencies to effectively implement the KALAHI CIDSS - NCDDP Program.
2. Initiate mechanisms and venue to maximize the involvement of all member agencies in the LGU.
3. Build convergence of programs and interventions during the process of implementation of the Program.
4. Provide relevant data to the barangays to facilitate needs assessment and analysis to provide technical assistance in the implementation of the barangay sub-projects.
5. Promulgate regulations as may be necessary for the effective implementation of the Program.
6. Monitor and oversee the strict implementation of the Program.
7. Direct other agencies to respond to the issues and concerns during the implementation of the program.

Section 4. Accountability and Reporting

The MIAC shall ensure that appropriate reports and other project documents be provided to the Local Chief Executive and the Committee.

Section 5. Effectivity

This Order takes effect upon its approval.
