MUNICIPAL ORDINANCE NO. 35

Introduced by: Hon. Lucas A. Bugatti

AN ORDINANCE PRESCRIBING THE FEES FOR THE DIAGNOSTIC SERVICES BEING RENDERED AT THE RURAL HEALTH UNIT OF HUNGDUAN, IFUGAO

WHEREAS, since the devolution of health services to Local Government Units by virtue of the passage into law of Republic Act No. 9160 otherwise known as the Local Government Code of 1991, the Municipal Government of Hungduan, Ifugao established its Rural Health Unit for the continuous delivery of basic health services to its constituents;

WHEREAS, since its operation, there is no fixed fees for diagnostic services being rendered at the Rural Health Unit, and in order to sustain the same, this body deemed it best to enact an ordinance to legalize the collection of fees by the Municipal Health Office from its patients;

NOW THEREFORE on motion of Honorable Ruben P. Wacoy and upon unanimous vote,

BE IT ORDAINED by the Sangguniang Bayan of Hungduan, Ifugao to enact the foregoing ordinance, to wit:

Section 1. Title. This ordinance shall be known and cited as "**AN ORDINANCE PRESCRIBING THE FEES FOR THE DIAGNOSTIC SERVICES BEING RENDERED AT THE RURAL HEALTH UNOT OF HUNGDUAN, IFUGAO.**"

Section 2. Scope. This Ordinance shall apply to all patients referred for diagnostic services to the Rural Health Unit whether resident or not of the Municipality of Hungduan, Ifugao.

Section 3. fees. The fees to be collected from every patient for diagnostic services rendered shall be as follows:

a. Nebulization	Php	30.00
b. Suturing		70.00
c. Fecalysis		50.00
d. Urinalysis		50.00
e. Malarial Smear		50.00
f. CBC		80.00
g. Platelet count		160.00
h. Pregnancy Test		100.00
i. Hepa BsAg		120.00
j. FBS		130.00
k. Blood Chem		700.00

Section 4. Payment. The payment of the aforementioned diagnostic fees shall be done at the Rural Health Unit who shall forthwith remit the same every end of the week to the Municipal Treasury Office for proper accounting. The fees collected from the diagnostic services shall be treated as special trust fund and the same shall be used for the purchase of laboratory reagents.

Section 5. Repealing Clause. Any ordinance, rules and regulations inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

Section 6. Effectivity. This Ordinance shall take effect immediately after its approval subject to the requirements prescribed under Section 54 of the Local Government Code of 1991.
