ORDINANCE CREATING THE POSITIONS OF MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT OFFICER (MSWDO) AND MUNICIPAL AGRICULTURIST (MA) IN THE MUNICIPALITY OF HUNGDUAN, IFUGAO AND APPROPRIATING FUNDS THEREFOR.

BE IT ORDAINED by the Sangguniang Bayan of Hungduan, Ifugao assembled in session to enact the foregoing ordinance, to wit:

Section 1. Title: This ordinance shall be known and cited as: An Ordinance creating the positions of Municipal Social Welfare and Development Officer (MSWDO) and Municipal Agriculturist (MA) in the Municipality of Hungduan, Ifugao and appropriating Funds therefor.

Section 2. Legal Basis: Section 447 (a)(viii) of the Local Government Code of 1991 provides that the Sangguniang Bayan shall determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds and provide for expenditures necessary for the proper conduct of programs, services and activities of the municipal government.

Section 3. Duties and Functions: The Municipal Social Welfare and Development Officer shall perform the duties and functions provided for under Section 483, Article XIII of the Local Government Code of 1991. Likewise, the Municipal Agriculturist shall perform the duties and functions provided for under Section 482, Article XII of the same Code.

Section 4. Salary Grade and Funding Source: The Municipal Social Welfare and Development Officer and the Municipal Agriculturist shall receive a monthly compensation corresponding to Salary Grade twenty-four (24) which shall be charged against the appropriation for Personal Services under the Appropriation Ordinance beginning Fiscal Year 2015 of the Local Government of Hungduan, Ifugao.

Section 5. Separability Clause: If for any reasons, any provision of this ordinance is declared unconstitutional or invalid by the court, or revoked by competent authorities, the remaining provisions not affected thereby shall continue to remain in full force and effect.

Section 6. Repealing Clause: Any previous ordinances, rules and regulations or parts thereof that are in conflict/inconsistent with any provisions of this ordinance are hereby repealed, amended or modified accordingly.

Section 7. Effectivity: This ordinance shall take effect upon its approval.
