**AN ORDINANCE PROVIDING THE MONTHLY CASH INCENTIVE OF BARANGAY NUTRITION SCHOLARS (BNS) AND BARANGAY HEALTH WORKERS (BHWs) IN THE MUNICIPALITY OF HUNGDUAN, IFUGAO TO ONE THOUSAND PESOS (PHP 1, 000.00) AND THREE HUNDRED FIFTY PESOS (PHP 350.00) RESPECTIVELY.**

**BE IT ORDAINED** by the Sangguniang Bayan of Hungduan, Ifugao duly assembled in session to enact the foregoing ordinance, to wit:

**Section 1. TITLE.** This ordinance shall be known and cited as: “an ordinance providing the monthly cash incentive of Barangay Nutrition Scholars (BNS) and Barangay Health Workers (BHWs) in the Municipality Of Hungduan, Ifugao to one thousand pesos (Php 1, 000.00) and three hundred fifty pesos (Php 350.00) respectively.

**Section 2. LEGAL BASIS.**

- a. Section 468 (a)(1)(viii) of the Local Government Code of the Philippines; and
- b. Republic Act No. 7883, otherwise known as the Barangay Health Worker’s Benefits and Incentives Act of 1995.

**Section 3. DEFINITION OF TERMS.** For purposes of this ordinance, the following terms shall be defined, to wit:

- a. Cash Incentive-Refers to the monthly cash assistance given to Barangay Nutrition Scholars and Barangay Health Workers from the coffers of the Municipal Government in such amount as herein provided.
- b. Barangay Nutrition Scholar- Refers to the volunteer community workers who are trained in implementing health and Nutrition programs in the locality.
- c. Barangay Health Worker-Refers to a person who has undergone training programs under any accredited government and nongovernment organization and who voluntary renders primary health care services in the community.

**Section 4. MONTHLY CASH INCENTIVE FOR BARANGAY NUTRITION SCHOLARS AND BARANGYA HEALTH WORKERS.** Beginning in the year 2015, the monthly cash incentive for Barangay Nutrition Scholars and Barangay Health Workers shall be One Thousand Pesos (Php 1, 000.00) and Three Hundred Fifty Pesos (Php 350.00) respectively.

**Section 5. FUNDING SOURCE.** The contemplated cash incentive in the

immediately preceding section shall be included under the Statutory and Contractual Obligations item in the regular annual budget of the municipality.

**Section 6. RELEASE OF THE CASH INCENTIVE.** Quarterly cash incentives shall be processed upon the submission of the concerned BNS and BHWs of the required monthly reports to the Public Health Nurse, who in turn, shall recommend the release of said incentives.

**Section 7. SEPARABILITY CLAUSE.** All provisions of existing ordinances, resolutions and executive orders of the Municipal Government of Hungduan, Ifugao inconsistent with this ordinance are hereby deemed repealed.

**Section 9. EFFECTIVITY.** This ordinance shall take effect immediately upon approval thereof.
